## **How to obtain reproductions from George Eastman House**

1. Identify the George Eastman House photograph you'd like to use.  
<http://www.geh.org/>
2. Identify the photographer and copyright holder. Obtain contact information.  
If there is no copyright holder proceed to step 4.

3. Request permission to use image from copyright holder, pay fee, if necessary, and get written proof. Please allow several weeks for this process.
4. View George Eastman House Image Use Policy and fees. (Agree to conditions)

5. Fill out on line order form. (Agree to conditions)

6. George Eastman House issues an invoice to your email address.
7. Fax your paid invoice back along with your proof of permission.  
If you choose to pay by bank transfer, image delivery will be after we receive the payment. There is an additional \$25. added for bank transfer payments. Please allow about four weeks for bank transfers. Bank transfer is on the last page of this document.
8. George Eastman House initiates the work and delivers images. Please allow two weeks. Large orders may take longer.

## Image Use Policy

1. Reproduction fees are based on non-profit or commercial intent of use. PREPAYMENT OF OUR FEES IS REQUIRED BEFORE IMAGE DELIVERY. Please make checks payable to George Eastman House. Major credit cards are accepted.
2. Payment does not confer or express the museum's permission to publish or exhibit copyrighted material in the museum's collection. It is the user's responsibility to obtain necessary permissions and pay required fees for the use of copyrighted material. Users are held fully responsible for any infringement of copyright. PROOF OF PERMISSION IS REQUIRED BEFORE IMAGE DELIVERY. The contact addresses of many of the copyrighted photographers in our collection are listed in Copyright Information in the column on the left.
3. Delivery time varies with the size and complexity of the order. Some orders can be given RUSH priority, depending on the nature of the order, availability of the material, and our photographer's work schedule.
4. Photographs furnished by George Eastman House may not be cropped, manipulated, overprinted, printed in colored ink or altered in any form without permission. A sample layout should accompany a request for an exception.
5. All photographs must be accompanied by the credit line: Courtesy of George Eastman House, International Museum of Photography and Film. In print the credit line must appear with the image on the same or facing page. In film and video the credit line must appear with the picture credits. In exhibitions, the credit line should appear with the photograph or within the exhibition area.
6. All reproduction materials remain property of George Eastman House and are to be returned after use. Research prints and prints for personal use need not be returned. Research prints and prints for personal use are not for resale.
